

Retail Ready Product Designations

Effective May 01, 2025

Any product intended to be created and/or sold that is not included in this document must be submitted to the Cannabis Office for review and designation before it is permitted to be eligible for sale at a cannabis establishment. Pursuant to 560- RICR-10-10-2.4, product designation(s) may be withdrawn, denied or revoked by the Cannabis Office ("CO") if the product fails to satisfy any provision of the Rhode Island Cannabis Act, R.I. Gen. Laws Chapter 21-28.11, the Edward O. Hawkins and Thomas C. Slater Medical Marijuana Act, R.I. Gen. Laws Chapter 21-28.6, or the Rules and Regulations Related to the Operational Requirements For Cannabis Establishments, 560-RICR-10-10-2, or if the product deviates or is altered from its previously approved form.

The below products have been designated to be available for sale to an adult-use consumer and/or to a patient, caregiver, or authorized purchaser based on the designation category and accompanying requirements, including but not limited to, passing enforced compliance testing results reported by a RI licensed cannabis testing facility.

Bud/Flower (Adult-Use and Medical)

- Pre-Packaged Raw Flower
- Pre-Rolls with flower only
- Infused Pre-Rolls with designated concentrate(s) added to it
- Infused flower or pre-ground flower with designated concentrate(s) added to it
- Prohibited additives include caffeine, nicotine, tobacco, or other unapproved substances

Concentrates Intended for Vaporization (Adult-Use and Medical)

- 100% cannabis with no added ingredients
- No flavor or coloring has been added except those derived solely from cannabis and have been procured in accordance with applicable Rhode Island laws
- No vitamin E acetate has been added
- An ingredient list for each unique product has been submitted to the CO
- Prohibited additives include nicotine, tobacco, or other unapproved substances

Concentrates Intended to be Inhaled (Adult-Use and Medical)

- 100% cannabis with no added ingredients
- No flavor or coloring has been added except those derived solely from cannabis and have been procured in accordance with applicable Rhode Island laws
 - May include added hemp-derived terpenes that have been approved for External Transfer by the CO

- O May include hemp-derived non-synthetic/non-psychoactive cannabinoids that that have been approved for External Transfer by the CO
- Prohibited additives include nicotine, tobacco, or other unapproved substances

Tinctures (Adult-Use or Medical)

- May include added hemp-derived terpenes that have been approved for External Transfer by the CO
- May include hemp-derived non-synthetic/non-psychoactive cannabinoids that that have been approved for External Transfer by the CO
- May contain up to 500mgs of THC as reported by licensed testing facility per packaged product

Tinctures (Medical Only)

Tinctures are designated "ingestible" product types and therefore, may contain THC amounts greater than 500mgs per package but are available for sale **ONLY** to a medical patient, caregiver or authorized purchaser

- May include added hemp-derived terpenes that have been approved for External Transfer by the CO
- May include hemp-derived non-synthetic/non-psychoactive cannabinoids that that have been approved for External Transfer by the CO
- May contain more than 500 mgs of THC per package, for medical patient, caregiver or authorized purchasers <u>ONLY</u>

Cannabis Infused Edible Products (Adult-Use and Medical)

The below products must be tested by a licensed RI cannabis testing facility in final form and found to contain equal to or less than 10 mgs of THC per serving (a 10% variance is allowable). Products designated as "Edibles" are required to adhere to the 10 mgs of THC per serving and 100mgs of THC per package requirement regardless of whether they are sold to an adult-use consumer or medical patient/caregiver or authorized purchaser.

- Baked Goods
- Gummy/Fruit Chews
- Chocolate/Caramels
- Lozenges
- Carbonated Beverages
- Fruit Drinks
- Coffee/Tea
- Culinary Additives
- Frozen Desserts
- All products must be in the allowable forms as listed below:
 - O No neon or fluorescent colors
 - O Cannot appeal to minors
 - O Cannot be on a stick.
 - O Cannot be in the shape of a cannabis leaf or plant
 - O Cannot resemble a trademarked consumer product

Cannabis Infused Non- Edible Products (Adult-Use)

The below products are designated "Cannabis Infused Non-Edibles" and are intended for sale to adult-use consumers must be tested by a licensed RI cannabis testing facility in final form and found to contain equal to or less than 10 mgs of THC per serving (a 10% variance is allowable). These product types when sold to an adult-use consumer are required to adhere to the 10 mgs of THC per serving and 100mgs of THC per package requirement.

- Capsules/tablets only for oral consumption
- Topicals including Transdermal Topicals
- Metered Dose Inhalers
- All products must be in the allowable forms as listed below:
 - o Cannot be on a stick
 - o No neon or fluorescent colors
 - o Cannot appeal to minors
 - o Cannot be in the shape of a cannabis leaf or plant

Cannabis Infused Non- Edible Products (Medical Only)

The below products are designated "ingestible" product types and therefore, may contain THC amounts greater than 10mgs per serving but are available for sale **ONLY** to a medical patient, caregiver or authorized purchaser. These products must be tested by a licensed RI cannabis testing facility. A 10% variance is allowable with regards to the THC content per serving.

- Capsules/tablets only for oral consumption
- Topicals including Transdermal Topicals
- Metered Dose Inhalers

RSO (Adult Use)

- May include added hemp-derived terpenes
- May include hemp-derived non-synthetic/non-psychoactive cannabinoids
- When sold to adult-use consumers RSO must adhere to the 10 mgs of THC per serving and 100mgs of THC per package requirement
- Prohibited additives include nicotine, tobacco, or other unapproved substances

RSO (Medical Only)

RSO is a designated "ingestible" product type and therefore, may contain THC amounts greater than 10mgs per serving but are available for sale **ONLY** to a medical patient, caregiver or authorized purchaser. These products must be tested by a licensed RI cannabis testing facility. A 10% variance is allowable with regards to the THC content per serving.

- May include added hemp-derived terpenes
- May include hemp-derived non-synthetic/non-psychoactive cannabinoids
- Prohibited additives include nicotine, tobacco, or other unapproved substances
- May contain more than 10mgs of THC per serving but are available for sale <u>ONLY</u> to a medical patient, caregiver or authorized purchaser
