Approved Hemp Cultivars for Performance Based Sampling

Issued pursuant to 230-RICR-80-10-1 Rhode Island Industrial Hemp Program Effective Date: 1/30/2025

On 8/14/2024, updates to Rhode Island's Industrial Hemp Program regulations came into effect and, as a result, introduced the opportunity for Grower licensees to reduce their sampling burden under the performance-based sampling program. The following list contains varietals of hemp grown for fiber and grain production that qualify for performance-based sampling.

The purpose of this guidance document is to provide an overview of these updated conditions for current and future licensees. This is *not* a substitution for licensees thoroughly reviewing and understanding the regulations which are <u>available here</u>.
