Note: The discussion and votes on the Commission’s proposed regulations is a procedural step to authorize the staff to proceed with the rulemaking process required by the APA. Once all four draft regulations are approved by the Commission, the staff will proceed with the process to post the regulations with the RI Secretary of State’s office for a 30-day public comment period and provide notice of a public hearing on these regulations. Instructions for accessing the regulatory documents and submitting public comment will be emailed to the Commission’s interested parties list and posted on the Commission’s website within a few days of this meeting.
